Appeal Decision: Dismissed

PL/10711 - Installation of a solar farm with a generating capacity of up to 4.9MW (AC) for a temporary period of 30 years, including associated infrastructure, permanent grid connection hub and environmental enhancements - Ty Maen, Rhos, Llandysul, SA44 5AH - concern was raised about all the transport the residents would have to endure while the farm was being built. The Council is also of the opinion that the road is narrow and that the road surface needs to be improved for the heavy traffic that is likely to travel on it for the construction work.
